### Reporting Domain

The college calendar file will be reported once annually, within 30 days following the end of the Spring term for the forthcoming academic year. The file will contain a separate record for each day of the year, commencing with the record for July 1st.

The Term-Identifier (GI03) should reflect an annual submission of "0" and the last year of the college calendar being reported. For example, report "110" for the college calendar year beginning with July 1, 2010 and ending with June 30, 2011.

This record is 20 characters long. The first two positions contain the record code "CC".
